TB-500:

So this is mainly used to to promote healing, the creation of new blood and muscle cells and as an anti-inflammatory. Its prohibited under Section S2 of the Prohibited List. Its not specified on the List itself but it would fall under this clause at the end of the section; "as well as any other growth factor affecting muscle, tendon or ligament protein synthesis/degradation, vascularisation, energy utilisation, regenerative capacity or fibre type switching and other substances with similar chemical structure or similar biological effect(s) ...".
