I am not seeking any personal information, just the total number of TUEs obtained by each county.

Also, I understand that the usage and frequency of TUEs being obtained by various teams is subject to monitoring and review on a regular basis. I would appreciate it if you could provide me with any general findings on TUE usage within GAA.

If possible, I would like to receive information from 2012 to the present day.
